

## **Aluma Connect: Parental Consent Form**

**Children under the age of 13 are prohibited from using and to use the Aluma Connect Site and Services without express written permission of a parent or legal guardian.**

**A parent or guardian must submit this form in order to add a child under 13 to your Family Account and to your Social Safety Network affiliated with your Account.** Once you have granted consent for the child to use the Service, Aluma will collect information such as name, email address, mobile phone number, device ID, and motion sensor and location data including GPS, WiFi and mobile location.

Aluma will disclose this information to other members of the individual Social Safety Network affiliated with your Account that have permission to access this information, and the child will be able to send and receive messages to members of the Social Safety Network.

Access to the individual Social Safety Network affiliated with your Account is invite-only. Aluma may also share personal information, including location data, collected from a child under 13 with our third party service providers or partners, as described in our Privacy Policy (<http://www.alumalife.com/privacy-policy/>). However, we will not use or share personal information associated with any account registered by a parent for a child under 13 with third party partners for advertising purposes.

Parent or guardian consent is required for the collection, use or disclosure of information from children under the age of 13. Aluma Connect will not collect this information without consent.
